

ORD. 57-A (YARD SALES)

AN ORDINANCE TO AMEND ORDINANCE NO. 57  
OF THE CITY OF HAMPTON ENTITLED  
"AN ORDINANCE REGULATING YARD SALES, GARAGE SALES  
AND OTHER SUCH SALES CONDUCTED WITHIN  
THE CITY OF HAMPTON, GEORGIA"

WHEREAS, the Mayor and City Council recognize that it is in the public interest that the City amend its existing Ordinance No. 57 by adding certain language to the Ordinance;

NOW THEREFORE, BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF HAMPTON AND IT IS HEREBY ORDAINED BY AUTHORITY OF THE SAME AS FOLLOWS:

Section 1. Ordinance No. 57 of the City of Hampton is amended by adding the following paragraphs (d) and (e) to the existing Section 4 of said Ordinance:

SECTION 4 - LOCATION AND TIME.

(d) In the event a permit holder commences a yard sale under the terms of this Ordinance and the yard sale is interrupted or terminated for any reason, the holder of the permit shall not be allowed to restart the yard sale after the initial seventy-two hours without first obtaining an additional permit authorized under this Ordinance.

(e) If a permit has been issued for a yard sale, but the holder of the permit does not commence the yard sale for any reason, the holder of the permit may return the permit to the City Clerk and the City Clerk will issue a replacement permit at the time requested by the holder of the permit.

Section 2. Ordinance No. 57 of the City of Hampton is amended by adding the following paragraph (c) to the existing Section 5 of said Ordinance:

SECTION 5 - FEES.

(c) Fees paid for the above-stated permits are non-refundable. If a holder of a permit does not use the permit for the yard sale, then a replacement permit will be issued, but the fee paid will not be reimbursed.

Section 3. All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.
